Heather Haslip reported that in February 2015 the commission approved an amendment to the Interagency Agreement with Department of Enterprise Services (DES) and funding authorizations for design, construction, project management, and monitoring services for installation of a solar array on the Port-owned building located at 11966 Westar Lane.

Ameresco and their subcontractor, Artisan Electric, have completed design and construction of the 35.75 kWp solar array ahead of schedule and well within project budget.
